Parents Under Construction (PUC)

This 10-lesson curriculum is designed to teach middle and high school students skills that will positively influence their future parenting. Parents Under Construction enhances children's awareness of how parenting influences children's mental health. The program helps children today learn the parenting skills they will need in the future. This program increases the social and emotional competence of children and prevents physical abuse, emotional abuse, and mental health challenges now and in future generations.

During FY 15-16, we served 32 youth and students and trained 13 individuals.

We Help Ourselves (WHO)

WHO is an anti-victimization program that teaches children and adolescents how to stay safe, how to handle threatening situations, and how to get help. Children gain decision-making and communication skills and see themselves as capable, worthy human beings who do not deserve victimization of any kind. Trained facilitators deliver engaging, age-appropriate presentations on child abuse, internet dangers, bullying, domestic violence, sexual and emotional abuse, kidnapping, dating violence, and suicide.

During 2015-2016, we served 54,070 youth and students and trained 13 individuals.

Relationship Smarts PLUS formerly known as LOVE U2

This 12-lesson, evidence-based curriculum teaches middle and high school students how to build skills necessary for healthy relationships. Topics include self-awareness, goal setting, respect, boundaries, dating violence, communication, unplanned pregnancy, and social media. Each lesson is packed with engaging, hands-on, informative, and upbeat activities that build the skills and knowledge necessary to make wise choices and develop healthy relationships now and in the future.

During FY 15-16, we served 189 youth and students and trained 8 individuals.
