Texas Law

Dating Violence Policies (TEC Section 37.0831)

(a) Each school district shall adopt and implement a dating violence policy to be included in the district improvement plan under Section 11.252. (b) A dating violence policy must: (1) include a definition of dating violence that includes the intentional use of physical, sexual, verbal, or emotional abuse by a person to harm, threaten, intimidate, or control another person in a dating relationship, as defined by Section 71.0021, Family Code; and (2) address safety planning, enforcement of protective orders, school-based alternatives to protective orders, trainings for teachers and administrators, counseling for affected students, and awareness education for students and parents.

Child Abuse Reporting and Programs (TEC Section 38.004)

(a) The agency shall develop a policy governing the reports of child abuse or neglect, including reports related to the trafficking of a child under Section 20A.02(a)(5), (6), (7), or (8), Penal Code, as required by Chapter 261, Family Code, for school districts, open-enrollment charter schools, and their employees. The policy must provide for cooperation with law enforcement child abuse investigations without the consent of the child's parents if necessary, including investigations by the Department of Family and Protective Services. The policy must require each school district and open-enrollment charter school employee to report child abuse or neglect, including the trafficking of a child under Section 20A.02(a)(5) or (7), Penal Code, in the manner required by Chapter 261, Family Code. Each school district and open-enrollment charter school shall adopt the policy. (a-1) The agency shall: (1) maintain on the agency Internet website a list of links to websites that provide information regarding the prevention of child abuse; and (2) develop and periodically update a training program on prevention of child abuse that a school district may use for staff development. (b) Each school district shall provide child abuse anti-victimization programs in elementary and secondary schools.

Texas Law

Policies Addressing Sexual Abuse of Children (TEC Section 38.0041)

Each school district and open-enrollment charter school shall adopt and implement a policy addressing sexual abuse, sex trafficking, and other maltreatment of children, to be included in the district improvement plan under Section 11.252 and any informational handbook provided to students and parents. (b) A policy required by this section must address: (1) methods for increasing staff, student, and parent awareness of issues regarding sexual abuse, sex trafficking, and other maltreatment of children, including prevention techniques and knowledge of likely warning signs indicating that a child may be a victim of sexual abuse, sex trafficking, or other maltreatment, using resources developed by the agency under Section 38.004; (2) actions that a child who is a victim of sexual abuse, sex trafficking, or other maltreatment should take to obtain assistance and intervention; and (3) available counseling options for students affected by sexual abuse. (c) The methods under Subsection (b)(1) for increasing awareness of issues regarding sexual abuse, sex trafficking, and other maltreatment of children must include training, as provided by this subsection, concerning prevention techniques for and recognition of sexual abuse, sex trafficking, and all other maltreatment of children

What does David's Law do?

Law amends the Education Code provisions regarding bullying to better define and encompass cyberbullying. It encourages school districts to establish a district-wide policy related to bullying prevention and mediation. It provides for anonymous reporting for students, includes cyberbullying off campus and after school hours, and modifies the parental/guardian notification procedure. It provides flexibility in the disciplinary placement or the expulsion of students engaged in certain types of very serious bullying. It authorizes school principals to report certain incidents of bullying to local law enforcement and provides protection from liability for doing so. It expands the scope of instruction that can satisfy continuing education requirements for classroom teachers and principals to include instruction related to grief-informed and trauma-informed strategies. It requires the Texas Education Agency (TEA) to maintain a website with resources related to student mental health needs. Public schools, as well as open-enrollment charter schools, are subject to this law. Private schools are not included.

Stand Strong • Stay Safe Early Childhood

4 Hours

Curriculum Description

This prekindergarten through first grade curriculum teaches how to prevent victimization through assertiveness skill building. Through interactive presentations and role-play, children learn how to stay safe from bullying, emotional abuse, physical abuse, sexual abuse, and neglect. Follow-up activities, Home Connections, and a Parent Guide allow for ongoing practice and repetition to increase retention of the skills. There are four 20-minute lessons.

Stand Strong • Stay Safe Elementary

4 Hours

Curriculum Description

Five 30-minute lessons teach second through fifth grade students to set and defend personal boundaries, be assertive, and get help when faced with unsafe situations. The program uses a series of comic book style stories to introduce and discuss the concepts of boundaries, consent, physical abuse, sexual abuse, emotional abuse, and bullying. Practice and repetition are provided through group activities, role-plays, follow-up activities, and Home Connections.

Relationship Education

Relationship Smarts PLUS

8 Hours

Curriculum Description

This 13-lesson, evidence-based curriculum teaches middle and high school students how to build skills necessary for healthy relationships. Topics include self-awareness, goal setting, respect, boundaries, dating violence, communication, unplanned pregnancy, and social media. Each lesson is packed with engaging, hands-on, informative, and upbeat activities that build the skills and knowledge necessary to make wise choices and develop healthy relationships now and in the future.

Love Notes 8 Hours

Curriculum Description

Love Notes is an evidence-based pregnancy-prevention program for at-risk youth. In a 13-lesson adaptation of Relationships Smarts PLUS that integrates relationship skills with practical pregnancy prevention strategies, students learn how to make wise choices about partners, sex, relationships, pregnancy, and more.

Parenting Prep Education

Parents Under Construction

8 Hours

Curriculum Description

This 10-lesson curriculum is designed to teach middle and high school students skills that will positively influence their future parenting. Parents Under Construction enhances children's awareness of how parenting influences children's mental health. The program helps children today learn the parenting skills they will need in the future. This program increases the social and emotional competence of children and prevents physical abuse, emotional abuse, and mental health challenges now and in future generations.

Curriculum Content

- Increase knowledge of parenting responsibilities, demands, and costs

- Enhance their knowledge about mental health, and understand the relationship between parenting practices and the child's mental health

Build to Nurture 4 Hours

Curriculum Description

Build to Nurture is an eight-lesson, interactive curriculum which prepares children with the social and emotional skills they need to become caring, nurturing, and contributing members of their families and communities. It is easily integrated into prekindergarten through first grade classrooms with hands-on learning, center activities, and parental involvement through Home Connections. Lessons and strategies are used to improve the classroom climate and promote community and connection.

Dating Violence Prevention

Workshop Description

Dating violence is when one person intentionally physically, emotionally, and/or sexually abuses someone they are dating. Teens may not be aware of some of the early warning signs of an abusive relationship. This workshop will teach participants to identify healthy relationships, the signs of abusive behaviors, and how to get help.

Keeping Children Safe

Workshop Description

Participants will learn how to prevent victimization through the plan, anticipate, communicate, and practice- model. Participants will use the model and role-play scenarios they might face with their children, (for example, during play dates or Internet use). We recommend this workshop to follow the implementation of Stand Strong • Stay Safe presentations. The workshop is designed for parents to learn ways to keep their childrensafe.

Participants will learn different methods that can be used to help guide children toward wise choices, while keeping the dignity of the child intact. The parenting philosophies and approaches discussed are based on current experts in the field.

Workshops For Professionals

Recognizing and Reporting Child Maltreatment

Workshop Description

This workshop will give professionals a better understanding of child maltreatment and its prevalence in our community. They will learn how to get help for children, recognize the signs of abuse, be aware of the reporting laws, and know what to do when a child makes an outcry.
